

### **Taught Programme Transfer and Re-Admission Policy**

## 1 Purpose

The objective of the policy is to support and maximise progression, widen participation and retention, allowing as much flexibility as possible to ensure students are in programmes that suit their academic strengths and offer them the best prospect of achieving their full potential.

The University provides a number of mechanisms whereby current or former UCD students may apply to transfer to a new programme of study, re-enter a programme previously started but not completed, and prospective students may apply to enter into a UCD programme having undertaken learning at another Higher Education Institution.

### 2 Definitions

**Internal Transfer**: an applicant who is currently a UCD student<sup>1</sup>, or has previously attended but not completed, and is seeking to move to a different programme at the same NFQ level.

**External Transfer**: an applicant who is currently attending, or has previously attended but not completed, a programme in a Higher Education Institution (HEI) other than UCD and is seeking to gain entry to a similar or different programme in UCD at the same NFQ level.

**Progression Applicant**: an applicant who is seeking to enter on the basis of a completed recognised NFQ level 5, 6 or 7 qualification (normally QQI-FET or HETAC and certain linked UCD programmes).

**Re-Admission Applicant**: A former UCD student who did not complete an award<sup>2</sup> and who is seeking to return to the same programme in UCD. Applicants whose registration to a programme has previously been discontinued or terminated will also have their application considered under the relevant UCD policy.

**Programme**: This is the course of study, for example, BA Degree. Each programme will have a set number of stages and credits that you need to complete to get a University award (degree, diploma or certificate).

**Stage**: A student will progress through an undergraduate programme in stages. An undergraduate stage is normally completed when a student successfully accumulates 60 credits. For full-time undergraduate students, a 60-credit stage will normally be completed in one academic year.

EU/Non-EU: Status as an EU or non-EU applicant is defined based on the fees criteria.

## 3 Scope

This document details the University's transfer policy for managing and processing programme transfer/re-admission requests and applies to:

Undergraduate EU applicants (see sections 5)

Undergraduate non-EU applicants (see sections 6)

Graduate Taught applicants (see section 7).

## 4 Principles

### 4.1 General Principles – all applicants

- All applications for transfer/re-admission are subject to availability of places and adherence to this policy.
- Current UCD students must remain fully registered to their original programme of study until a programme transfer is approved and fully processed.
- With the exception of UCD <u>recognised progression routes</u>, undergraduate transfers will only be considered from NFQ Level 8 programmes.
- Applicants are responsible for initiating transfer/re-admission requests and should seek information about possible options before making applications.
- Applicants must meet the academic requirements for the stage they wish to enter (e.g. any
  pre- requisites, co-requisites or accepted equivalences). The Governing Board shall determine
  the academic requirements to be met by the applicant.
- Applicants whose registration to a programme has previously been discontinued or terminated will also have their application considered under the relevant UCD policy.
- The policy shall uphold the University's strategic commitment to Equality, Diversity and Inclusion, to ensure that it will not negatively impact an individual as a result of their membership of a group, represented under UCD's equality grounds.
- For a UCD degree to be awarded, at least half the overall programme credits must normally have been earned in UCD.
- Transfer may have a direct impact on tuition-related fees and charges. Students will be expected to pay fees on a pro-rata basis with fee exemptions offered for modules that have been transferred. Students who qualify for "free fees" may be required to pay University fees for a period equivalent to previous attendance (see <a href="https://www.ucd.ie/fees">www.ucd.ie/fees</a>).
- A student who accepts an offer of another programme ceases to be a student of the original programme. Internal transfers who change their mind about the new acceptance within the first three weeks of the trimester may be permitted to change back to the original programme, subject to availability of places and with the agreement of Admissions and all relevant Governing Boards<sup>3</sup>.
- In line with the Admissions Policy, offers for taught programmes will not be made after the third week of a trimester.
- A number of programmes place restrictions on applications and will not normally consider
  - o applications from those who have been unsuccessful (i.e. failed to meet programme requirements) in similar programmes in UCD or at another HEI, or
  - applicants with issues that may affect their ability to register with a relevant professional body such as the Irish Medical Council and Nursing and Midwifery Board of Ireland.

In exceptional circumstances Governing Boards may decide to consider such applications. Applicants may present their case in writing to the Director of Admissions. A list of programmes

applying restrictions on transfer applicants is published on the restrictions page at www.ucd.ie/transfer.

Students who are admitted will be bound by the UCD <u>Academic Regulations</u>. In some cases, students may wish to apply for Recognition of Prior Learning in addition to that granted by the transfer process (see Recognition of Prior Learning (RPL) policy)

## 5 EU Undergraduate Transfer/Re-Admission applications

- Details of application procedure and closing dates are available at <a href="www.ucd.ie/transfer">www.ucd.ie/transfer</a>.
- As applications are assessed as soon as possible after the closing date, applicants awaiting
  results of later examinations will only be considered if they are received in sufficient time to
  make offers within three weeks of the start of trimester AND places remain following initial
  offers.
- Deferral or Leave of Absence is not permissible for the trimester following acceptance of a transfer/re-admission offer.
- At the discretion of the Governing Board, an applicant may use a successfully completed
  university examination to meet certain subject entry requirements (e.g. Stage 1 Mathematics
  as a substitution for a school-leaving Mathematics requirement). If an applicant wishes to
  meet requirements in this way, they must initiate this request with UCD Registry Admissions.

### 5.1 Transfer/Re-admission to commence Stage 1

This section applies to those who wish to enter Stage 1, Trimester 1 of a programme<sup>4</sup> of study in UCD.

The programme transfer application is made via CAO while the transfer of modules and credits is managed by UCD Registry on the recommendation of the Governing Board (see RPL policy). These involve two separate application procedures.

Applications are made via CAO and, will be assessed<sup>5</sup> in competition with other applicants on the basis of their school-leaving examinations or meeting the requirements of relevant access routes such as Mature Years. Applicants must declare previous third level attendance on the CAO form regardless of whether examinations were completed or not. Failure to declare a previous third level attendance could result in an application being invalidated.

## 5.2 Transfer at the start of Stage 1 (Internal Applicants Only)

This section applies to students who have accepted a UCD offer via CAO and are registered to Stage 1 of that UCD programme in the current year. This transfer opportunity will only be available where there is adequate time<sup>6</sup> after the last CAO reply date to allow for the offer to issue before third week of a 12-week trimester has elapsed (in line with UCD Admissions Policy).

Students may apply for transfer to Stage 1 of another UCD programme, if places remain in that programme following the close of the CAO offer season in the current year and if timing of CAO offers allows. Applicants who entered via an accepted alternative entry route (e.g. mature years, HEAR, DARE, QQI-FET) can be considered if places remain in that category's quota.

Students must meet the full entry requirements of the target programme, including current years points required for entry, subject requirements and any additional tests or entry criteria.

Where the number of eligible applicants exceeds the number of places available, applicants will be ranked on their points and random selection will apply where appropriate.

As there will be a very short timeframe in which to accept an offer, the onus is on the applicant to ensure they have adequately researched their choice. Once the offer is accepted, it will not be possible to return to the previous programme.

### 5.3 Transfer/Re-admission during a Stage

This section applies to students who wish to apply to the Spring Trimester of a Stage and is subject to the following conditions:

There must be places available in the new programme. In general, all programmes are full at the start of term and vacancies will only arise if students withdraw or fail to progress. An indicative list of available places is published at www.ucd.ie/transfer.

Applicants must meet the minimum entry requirements of the programme or meet the requirements for admission via an accepted alternative entry pathway (e.g. Mature or QQI-FET).

### For entry to Stage 1:

Applicants must have the current years points<sup>7</sup> required for entry to the target programme<sup>8</sup> and

Have passed a minimum of 20 ECTS credits, including sufficient modules and grades relevant to the new programme they are seeking to enter<sup>9</sup>. For the application to be successful it must be possible for the student to progress to stage 2 at the end of the academic year (in accordance with section 5 of the Academic Regulations).

### For entry to stage 2 or later:

Applicants must have passed at least 60 ECTS credits<sup>10</sup> for each previous stage, in addition to 20 ECTS credits for the autumn trimester of the stage they are seeking to enter, including sufficient modules and grades relevant to the new programme<sup>5</sup>. External applicants must have a minimum points standard from their school-leaving examinations (see <u>Appendix A</u>). If applicants entered via an accepted alternative entry pathway, they must meet the requirements via that route (see <u>Appendix A</u>).

For the application to be successful it must be possible for the student to progress to the next stage at the end of the academic year (in accordance with section 5 of the Academic Regulations).

Where the number of eligible applicants exceeds the number of places available, the relevant Governing Board will make decisions based primarily on both the compatibility of the modules completed and the student's academic performance in their previous third level studies. Where required, the assessment may also include a personal statement, school-leaving examination results or other relevant entry criteria.

### 5.4 Transfer/Re-admission to commence Stage 2 or a later stage

This section applies to students who wish to apply to commence Stage 2 or a later stage, in the Autumn Trimester of a different programme and is subject to the following conditions:

There must be places available in the new programme. In general, vacancies will only arise if students withdraw or fail to progress. An indicative list of available places is published at <a href="https://www.ucd.ie/transfer">www.ucd.ie/transfer</a>.

Applicants must meet the subject entry requirements for admission to the new programme. External applicants must have a minimum points standard from their school-leaving examinations (see <u>Appendix A</u>). If applicants entered via an accepted alternative entry pathway, they must meet the requirements via that route (<u>Appendix A</u>).

and

have passed 60 ECTS credits<sup>6</sup> for each previous stage of their third level studies, including sufficient modules and grades relevant to the new programme for the Stage and Trimester they are seeking to enter. If the student is permitted to transfer, it should be possible for them to progress to the next stage at the end of the academic year (in accordance with section 5 of the Academic Regulations).

Where the number of eligible applicants exceeds the number of places available, the relevant Governing Board will make decisions based primarily on the compatibility of the modules completed and the student's academic performance in their previous third level; the assessment may also include a personal statement, school-leaving examination results or other relevant entry criteria.

Applicants who do not have sufficient relevant credits for Stage 2 admission should apply via CAO for Stage 1 and, on admission, seek Recognition of Prior Learning.

### 5.5 Progression Routes

### **QQI HETAC Level 6/7 progression**

Transfer applicants who have attained a merit/distinction in a relevant award at NFQ Level 6 or 7 Higher Certificate/Ordinary Degree from an agreed transfer or progression route are considered for entry to some programmes. See www.ucd.ie/transfer for specific details of agreed routes.

Such transfers are subject to availability of places. An indicative list of available places is published at <a href="https://www.ucd.ie/transfer">www.ucd.ie/transfer</a>. Normally, applications are considered for entry to Stage 2 (or occasionally for Stage 3). For some programmes, applicants are considered for Stage 1 and should apply via CAO.

### **Progression within UCD**

There are a number of progression routes that are recognised within UCD. Typically, progression from certificate to degree is considered for stage 1 and from diploma to degree for stage 2. Full details are available in the progression section of the transfer website.

## 6 Non-EU Undergraduate Transfer/Re-Admission

### 6.1 Transfer/Re-admission to commence Stage 1

This section applies to those who wish to enter Stage 1, Autumn Trimester of a programme<sup>11</sup> of study in UCD.

Applications are made via <a href="www.ucd.ie/apply">www.ucd.ie/apply</a> and, will be assessed 12 in competition with other applicants on the basis of their academic record or meeting the requirements of relevant access routes such as Mature Years. Applicants must declare previous third level attendance on the form regardless of whether examinations were completed or not. Failure to declare a previous third level attendance could result in an application being invalidated.

## 6.2 Transfer/Re-admission during a Stage – Current/previous UCD students only

This section applies to UCD students who wish to apply for transfer after the Autumn Trimester of a Stage. This type of transfer is subject to the following conditions:

There must be places available in the new programme. In general, all programmes are full at the start of term and vacancies will only arise if students withdraw or fail to progress. An indicative list of available places is published at <a href="https://www.ucd.ie/transfer">www.ucd.ie/transfer</a>.

Applications will be assessed as for section 5.3 above.

### 6.3 Transfer/ Re-admission to commence Stage 2 or a later stage

UCD Students should apply via <a href="www.ucd.ie/transfer">www.ucd.ie/transfer</a> and applications will be considered in line with Section 5.4 above.

Applicants seeking to transfer from other third level institutions should apply as non-EU applicants in the normal way and, if admitted, can then apply for Recognition of Prior Learning.

## 7 Graduate Taught Transfer/Re-Admission

Applicants to a graduate course on the basis of prior study completed either in UCD or another institution, unless covered by a pre-established arrangement (e.g. <u>Graduate Taught Pathways</u>), should <u>apply for admission</u> to Stage 1 in the normal manner and, where appropriate, seek <u>recognition of their prior learning</u>.

## 8 Roles and Responsibilities


Governing Boards are responsible for making decisions on applications seeking advanced entry and the approval of transfer of credits and grades.

On the recommendation of the Governing Board, the Director of Admissions will make offers to transfer, progression and re-admission applicants, based on the agreed policy.

# Appendix A: Points Requirement for External Transfer Stage 2 or later (EU applicants)



### Medicine (DN400)

Applicants for Medicine (DN400) should note that the point scores of their school-leaving examinations and HPAT Ireland assessment are combined.

### **Graduate Entry Medicine (DN401)**

Applicants for Graduate Entry to Medicine (DN401) must:

pass the stage preceding the stage they seek to enter and be within 3 points of the GAMSAT cutoff score

### or

achieve an overall grade equivalent to a 2.1 Honours classification in the stage preceding the stage they seek to enter and be within 6 points of the GAMSAT cut-off score.

### **Mature entry to Nursing and Midwifery**

Applicants for mature Nursing or Midwifery (DN450, DN451, DN452, DN453) must:

pass the stage preceding the stage they seek to enter and be within 3 points of the mature nursing cut-off score

achieve an overall grade equivalent to a 2.1 Honours classification in the stage preceding the stage they seek to enter and be within 6 points of the mature nursing cut-off score.

### **Alternative Entry Routes**

Applicants who entered their programme via one of the following alternative entry routes will be assessed as follows:

### DARE:

Applicants who were deemed DARE eligible when they entered their current degree programme will be considered if they meet the DARE <u>minimum admission requirements</u> which pertained to the UCD class they now seek to join.

### **HEAR**:

Applicants who were deemed HEAR eligible when they entered their current degree programme will be considered if they meet the HEAR <u>minimum admission requirements</u> which pertained to the UCD class they now seek to join.

### **Mature Years:**

Applicants who entered their current degree programme on grounds of mature years will be assessed on an individual basis.

### QQI-FET:

Applicants who hold an accepted QQI-FET award will be considered if they meet the minimum QQI-FET entry requirements and their FET points score is within 20 of the FET score which was required for entry to the UCD class they now seek to join

(e.g. if 390 FET points were required for CAO entry in 2022, applicants with 370 points are eligible to apply for entry to Stage 2 in 2023).
