Entry Requirements

- This programme is intended for applicants with a Law degree, or an interdisciplinary degree in which law was a major component. An upper second class honours, or international equivalent is required.
- Applicants holding a Graduate Diploma in Law can be considered.
- Exemption may be given to those with significant, relevant, practical experience or those with a relevant graduate qualification.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 in each element, and 6.5 or above in reading and writing), or equivalent.
