## Staff Profile

### Professor Eoin Carolan, Director of the UCD Centre for Constitutional Studies

Eoin Carolan is a Professor at the UCD Sutherland School of Law and a practising barrister. He is expert in Irish constitutional and administrative law, media law and comparative constitutional law. He is Director of the UCD Centre of Constitutional Studies and his academic career has taken him to both Harvard and UCLA Law Schools as a visiting researcher.

His most recent research examines the trust in government structures. He has been awarded significant European Research Council Funding for this project. He has authored and co-authored many books and, in 2011, he was awarded the Kevin Boyle Prize for Outstanding Legal Scholarship for "The New Separation of Powers: A Theory for the Modern State" which was described as 'a book that deserves to be widely read and widely debated' which "has made a lasting contribution to the discipline" (N.W Barber, University of Oxford, *Public Law*).

- This programme is intended for applicants with a Law degree, or an interdisciplinary degree in which law was a major component. An upper second class honours, or international equivalent is required.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 and 6.5 in reading and writing), or equivalent.
